CORPORATE PARTNER PROGRAM

FPMS wish to announce their Corporate Partner Program which is designed to assist your training needs and reduce your training costs. This program is available to companies and government departments once qualification criteria are met. (see below)

Companies

A partner member would receive a 5% rebate on their total training expenditure with FPMS undertaken during a twelve month period, paid at the end of the 12 months, or chose to receive 2 full fee free places to a FPMS training course.

This is in addition to the current discounts offered by FPMS for group training and multiple registrations for a FPMS training course.

A partner member may also book and pay for training within their current financial year, for training to be held in the following financial year (within first 6 months of the next financial year) and receive a 5% discount on the training cost. Again this would be in addition to the group training and multiple registration discounts that FPMS offer.

Government Departments

A partner member would receive 2 full fee free places to a FPMS training course, either public or group courses.

A partner member will also have the ability to book and pay for training within their current financial year, for training to be held in the following financial year (within first 6 months of the next financial year) and receive a 5% discount on the training cost. Again this would be in addition to the group training and multiple registration discounts that FPMS offer.

Qualification Criteria

Thirty participants attending any of the FPMS training courses listed below in a twelve month period, comprised of group or individual participants. Start date of last training course will be the method of calculation of end of twelve month period. Company or government department to nominate a contact person within their organisation to administer their involvement. Authorized company officer to give FPMS written confirmation and approval that they are aware of rebate payment and to nominate who and how this rebate payment will be administered.
